# The Police Knowledge Area...or PoLKA for short!

The Police Knowledge Area (PoLKA) has a rejuvenated JESIP Community. Initially started in 2013, the area needed a refresh, this has now been completed.

PoLKA remains the place for single agency police lessons, alongside Lessons Identified Debriefing (LID) for ambulance and National Operational Learning (NOL) for the FRS community.



Police colleagues are encouraged to follow and contribute to the JESIP Community on PoLKA, sharing learning and experiences helps to improve our future response.

### Changes to the JESIP team

For those with a long enough memory you will recall that the JESIP team was established in Sept 2012, at its peak the team numbered some 15 staff, a mixture of Emergency Services responders and staff and civil servants.

It has always been the aim that JESIP would be embedded into responder agencies business as usual arrangements and the national team would reduce in size as the level of support required diminished.



From the information provided by services on the embedding questionnaire over the past 12 months, it is now felt that services have reached a point of maturity where this can happen.

From July 1<sup>st</sup> there will be a team of two at the centre, this will consist of Carl Daniels continuing as the Deputy Senior Responsible Officer and Charis Taylor as the JOL Coordinator. This means that sadly, Paul Owen, our Police Senior User will leave the team and return to his Home force of Hampshire Constabulary at the end of June. We wish him all the best for his future and thank him for his time with the central JESIP team.

Where possible, we will still look to support services with their embedding activity, this includes providing assurances to Ministers of progress through the completion of the embedding dashboard. We are will be distributing it for completion by services, the closing date for returns will be the 3<sup>rd</sup> week of August 2019.

The team are delighted to announce that the Desktop version of the ever popular JESIP App is now available to download. This adds to the availability across iOS, Android and Windows phone devices,




but we haven't stopped there..... The App is also available as a web-based tool, meaning ANY device with a connection to the internet can access the app and its features without having to install it locally on the device.

complete a template for the JDM which is useful for helping to track decisions or for use as an agenda for


meetings as suggested in the Tactical Command Roles and Responsibilities. Thank you to West Sussex County Council for the suggestion and support with this.

# Combined Tactical Air Cell (CTAC).... First national guidance launched



Air assets are a vital resource for responders and the increasing use of them requires rigorous arrangements to be in place when multiple aircraft, either manned or unmanned are operating in crowded airspace.

The Combined Tactical Air Cell (CTAC) guidance has been developed with emergency services and military aircraft operators to provide guidance on the management of multiple air assets.


A CTAC should be set up for protracted major incidents involving three or more air assets from two or more agencies,

however requesting a CTAC should be *considered* in the early stages of any major incident or event where air support is likely to be

No, it's not a typo! these are the three words that precisely describe the centre spot at Wembley Stadium, as given by what3words - a system now being used by an increasing number of agencies around the UK.



what3words assigns every 3m x 3m square on Earth, 3 random words, making the communication of your location much easier, particularly in rural areas, at events or for large-scale operations.

There is a free app which can be found on the APP Store and Google Play stores and you can explore the map at map.what3words.com, but we are also looking at ways to integrate this into the JESIP APP in the future.

# AIRWAVE MULTI-AGENCY TALKGROUPS

The issue of commanders failing to use multi-agency talk groups at exercises has once again been identified. The benefits of using multi-agency talk groups are:

- Access to immediate information sharing to aid decision making
- Greater shared situational awareness
- Continual updating of the joint understanding of risk

Early identification of a talk group is essential and will support the multi-agency response. The talk group can be set up before all the commanders are on scene - control rooms can facilitate this to enable immediate information sharing, building commanders situational awareness before they co-locate, making the process on scene more efficient and as a result, decreasing the time taken to deploy staff.

The use of multi-agency talk groups should be reinforced through the monthly Airwave tests. Services are encouraged to record the outcomes of these tests for their own records. They should also share any lessons identified and notable practice on JOL online, just like North Wales Police did with their Airwave test process (NPO1166)

# NATIONAL RESILIENCE STANDARDS

The 2015 Security Defence and Security Review contained a commitment to produce a new set of resilience standards. With the first 12 published in 2018, there are now 15 standards covering various areas of civil protection. These will be extended over time, and individual standards will evolve in response to experience from implementation, user feedback and lessons identified.

The standards do not introduce any new duties on emergency responders. They set out expectations of good and leading practice for Local Resilience Forums (LRFs), which build on and complement statutory duties under the Civil Contingencies Act (2004) and other relevant legislation. The statements of good and leading practice reflect the consensus view of local emergency responders and the government departments and agencies who drafted, contributed and were consulted on these statements.

The standards have two functions: i) as a yardstick for assurance through self- assessment and peer review, and ii) as guidelines for continuous improvement. The standards are available on ResilienceDirect








#### LESSON IDENTIFIED TREND

A number of recent submissions have identified lessons regarding the failure to use of interoperability talk groups during incidents and exercises, and the detrimental effect this has had on the response.



The JOL team would advise responding agencies to review which staff are taking part in these monthly tests and ensure that those who may need to use the talk groups at incidents are involved in future tests.

# LESSON UPDATE WORKING AROUND RAIL

The JOL team have liaised with various agencies including colleagues from Network Rail.

All staff are reminded to adhere to their organisations current SOPs and guidance when working around the railways. Responding agencies should ensure their operational staff are aware of procedures when working around rail and the JOL team recommend this information is disseminated again within their organisation as a reminder.

Further information is currently being reviewed and will be shared with you once completed.

We continue to make improvements to the JOL Online system following feedback from Users. We have also added New categories to the Risk Type section including EU EXIT, drones and Marauding Terrorist Attack.
