

JESIP EMBEDDING

This document provides some high level information on the embedding process and the steps that should be taken to ensure your service has JESIP fully embedded.

Effective embedding of **JESIP**

The focus of the JESIP team for the past year has been to ensure that the JESIP ways of working are built into business as usual arrangements.

The ideal position is that JESIP is not referenced by name - but that it becomes the way we work, as a matter of routine. These are the expectations set by the Interoperability Board. There are now 4 key areas of JESIP which need to be embedded within each emergency service across the country.

The task areas are:

Area 1: Policies, plans and procedures should have JESIP fully embedded

Area 2: Ensure JESIP Awareness, Training and Exercising arrangements are in place

Area 3: Increase the use of JOL and embed into culture

Area 4: Local structure to support the embedding of JESIP including Roles and Responsibilities



Area 1: Policies, plans and procedures should have JESIP fully embedded

Services should ensure that they have the JESIP models and ways of working fully integrated into relevant policies, plans and procedures.

Plans would include, but are not limited to:

- Local operational response plans
- Command and control procedures
- Emergency and major incident plans

How do services do this?

- Ensure relevant documents contain the Decision Model (JDM) and M/ETHANE. IIMARCH should be included for briefings, or plans may even be written around this JESIP website here.
- All single sector models that perform the replaced with the relevant JESIP model.
- Ensure that a process is agreed and documented for sharing lessons onto JOL Online.

Area 2: Ensure JESIP Awareness, Training and Exercise Arrangements are in place

Services must ensure that the appropriate training, awareness and exercising arrangements have JESIP learning outcomes or exercise objectives embedded into them.

The key training and awareness requirements are below. We have included hyperlinks where necessary.

Area 3: Increase the use of JOL and embed into culture

Joint Organisational Learning (JOL) needs to be embedded so it is the standard for multi-agency learning. We need to ensure that we identify what worked well, in addition to what didn't work so well, at incidents and in training. This is to ensure that we identify what steps need to be put in place to ensure we all learn and improve future response.



Documents are available for download on the JESIP website to assist with embedding Joint Organisational Learning. These documents are:

- **JESIP Exercise Objectives** These are objectives that can be used during the planning phase of an exercise to ensure interoperability is tested appropriately.
- JESIP Umpire Evaluation Sheet To ensure that during an exercise, umpires observe the relevant activities and provide feedback on interoperability
- JESIP Multi-Agency Debrief Template An aide memoire to be used a part of a multiagency debrief, to ensure that lessons relating to interoperability are identified and discussed.

All multi-agency lessons and notable practice identified following an incident, exercise or training session, should be shared via <u>JOL Online</u>. The JOL Single Point of Contact (SPoC) has responsibility on behalf of their organisation/Local Resilience Forum to oversee this process.

As the recipient of all JOL communications from the centre, the JOL SPoC should ensure that information is shared across their organisation.

Area 4: Local structure to support the embedding of JESIP including Roles and Responsibilities

The roles of JESIP Strategic, Training Lead and JOL SPoC need to be in place across all emergency services, with the holders of these roles being familiar with their specific responsibilities. A process should also be in place to pass on the role when a person leaves post.

It is imperative that staff are provided with a thorough handover when they commence the role. The roles and responsibilities document can be found on the website under Downloads and then Documents of Interest or click the image on the right.

JESIP Roles and Responsibilities

To assist with the continued embedding and management of JESIP by services locally, it is imperative that services have and maintain the key roles that have direct responsibility for the oversight, delivery and embedding of all JESIP activities locally.

- The JESIP roles are:
 - Strategic Lead
 - Training Lead
 JOL SPoC(s)

Where not already done so, we would advise adding the roles into existing role profiles or writing the requirement to maintain these roles into relevant service policies and procedures. This will help to ensure that the JESIP roles are robustly embedded.
