## **Reason for Action**

Evidence through Joint Organisational Learning (JOL) from a number of multi-agency exercises has shown a significant number of specialist commanders with limited or no awareness of the JESIP Principles, the JDM/METHANE when working with other agencies. Critically this has led to observations of poor joint command and control of the exercises as JESIP is not understood or applied.

Evidence suggests this is a particular issue with staff specialising in CT or Firearms as many police services did not prioritise these commanders for training in the original JESIP commander training roll out.

Understanding and applying the JESIP principles and using the JDM with other commanders to make effective decisions together is a key learning outcome from attending the one day JESIP tri-service commander courses. It is essential all police services address this issue and ensure these specialist commanders are equipped with the interoperability skills and tools proven to provide an effective joint response to incidents, whatever their nature or scale.

## **Background Information**

This training issue has been identified via submissions to Joint Organisational Learning (JOL) along with a number of other related issues. These related issues have been successfully addressed as detailed below:

- Delivery of JESIP presentations at CT Commanders CPD training days
- FRS and Ambulance NILO's when required will be deployed to CT Police Operations Room (CTPOR)
  to bridge the information and intelligence gap from CTU to respective operational, tactical and
  strategic commanders at siege incidents.
- Associated police and multi-agency doctrine now reflects the joint emergency services interoperability principles and underpins joint working and joint decision making across all services at such.
