Summary of Issue / reason for action:	Recent incidents at a number of prisons across England have identified a lack of knowledge and understanding of JESIP to enable joint working between the emergency services and Tornado teams. A number of lessons have been identified through both the emergency services and the prison service implementing on the spot arrangements at these incidents. This inconsistency has impacted on clear and consistent emergency planning and response arrangements for a multi-agency response to prison unrest/riots across the UK.
JOL Recommendation and Action Required:	<p>Prison Officer Tornado team members to receive JESIP awareness input utilising the all staff e-learning package during their annual CPD training days at their national training centres.</p> <p>The cadre of National Instructors/Tornado team leaders attend JESIP training being held across South Yorkshire and South Central regional areas. This supports the location of the national training centres at Doncaster and Kidlington.</p> <p>Where Police forces have liaison officers for prisons, they are to provide an update and awareness of JESIP to respective Governors</p>
Learning Outcome:	<p>That the Prison Officer National Training Centre will:</p> <ul style="list-style-type: none"> Embed the JESIP all staff awareness package into annual training courses for tornado team members, thus enduring consistency and JESIP awareness for its staff
